CHANGES TO THE ENGLISH AND MATHS REGULAR MINIMUM REQUIREMENTS FOR APPRENTICESHIP STARTS FROM 22 AUGUST 2017 AND APPRENTICESHIPS REMAINING INCOMPLETE ON 22 AUGUST 2017.

Modifications to SASE came into effect on 22 August 2017. Accordingly, SASE publication DFE-00167-2017 applies both to new Apprenticeship starts from 22 August 2017 and all Apprenticeships commenced before and not completed by 22 August 2017.

The modifications allow for an exemption to the English and Maths regular minimum requirements for people with Special Educational Needs, Learning Difficulties or Disabilities. This means that adjusting the minimum requirements to Entry Level 3 in English and Maths can be considered by the provider, on an individual and case-by-case basis, where <u>all of the conditions</u> of the updated SASE section 18 (Intermediate level) or section 37 (Advanced level) for have been satisfied and can be evidenced.

Full details relating to the exceptions eligibility criteria are contained in:

Sections 15-23 of SASE for Intermediate Level Apprenticeships Sections 34-42 of SASE for Advanced Level Apprenticeships

When applying this exemption, providers must <u>STILL</u> consider how to enable the Apprentice to access further literacy and numeracy development – including Level 1 and Level 2 courses – as part of their overall training provision.

The modifications to SASE have also extended the list of qualifications that meet the minimum English requirements to allow for a British Sign Language (BSL) qualification, at the appropriate level, to be accepted as an alternative to a qualification in English, where **BSL** is the primary language of the Apprentice.

Section 5(f) of SASE for Intermediate Level Apprenticeships Section 28(f) of SASE for Advanced Level Apprenticeships

Furthermore, the SASE modifications have further extended the list of qualifications that meet the minimum English and Maths requirements to allow for the acceptance of a range of UK-wide qualifications, as an alternative to qualifications gained in England.

Sections 5(g-j) and 6(f-i) of SASE for Intermediate Level Apprenticeships Sections 28(g-j) and 29(f-i) of SASE for Advanced Level Apprenticeships

The modifications include reference to the new numerical grades in the reformed GCSE system and the **minimum** grade requirements. A grade 4 (new grading) will be considered equivalent to a grade C (old grading). A grade 2 (new grading) will be considered equivalent to a Grade E (old grading).

Please note that some frameworks may have English and Maths grade/level requirements that are <u>above</u> the SASE <u>regular</u> minimum requirements. The exceptions relating to the use of British Sign Language or Entry Level 3 qualifications, detailed above, <u>do not apply</u> to <u>industry-specific</u> minimum entry requirements. Please check specific framework documents to ascertain where this is the case and/or check directly with the Issuing Authority responsible for the framework.

This Apprenticeship Framework provides the skills and knowledge required to become competent in supporting the wider healthcare team.

Apprentices are employed in various support roles eg porter, housekeeper, switchboard operator, catering, gardener, records management, HSDU Technician etc. These roles are central to the smooth running of healthcare services. Apprentices gain the new skills and learning they need to carry out these job roles as well as preparing them for future employment and career progression within the health sector.

This work-based programme was designed and developed with employers.

Purpose of this framework

Summary of the purpose of the framework

Definition:

An Apprenticeship is a job with an accompanying skills development programme designed by employers in the sector. It allows the apprentice to gain technical knowledge and real practical experience along with functional and personal skills, required for their immediate job and future career. These are acquired through a mix of learning in the workplace, formal off the job training and the opportunity to practice and embed new skills in a real work context. On completion of the Apprenticeship, an apprentice will be able to undertake the full range of duties, in the range of circumstances appropriate to the job, confidently and competently to the standard set by the health sector.

About the health sector:

The health sector comprises those working in the NHS (public sector) as well as voluntary and private healthcare providers and employs over 2 million people. The range of roles within the sector is very varied and the NHS careers site lists in the region of 300 different jobs. Individuals are likely to stay within the health sector for the majority of their working lives although they are also likely to change between different job roles and different employers as their career progresses.

Whilst all roles in the health sector are open to both male and female applicants, a large proportion of the health sector workforce is female. This is due in part to the flexible terms and conditions many employers offer but also varies from role to role. As a whole the workforce within the health sector tends to reflect the population within the local community it serves. As the UK population as a whole becomes older and lives longer so does the healthcare workforce. Widening participation policies apply and health sector employers recruit accordingly and may use their apprenticeship schemes as a means to address some of these issues.

There is a range of challenges for the health sector as a whole: an ageing population creates higher demand for services and ongoing care; patients have a greater choice of which services and treatments they access; and the current economic climate means that budgets are tight. Apprenticeships are one of the many ways in which employers within the health sector are seeking to address some of these increasing pressures. A qualified and competent support workforce is vital to the patient experience and to the smooth running of services.

About this framework:

This framework supports the broad vision of the sector to develop an increasingly skilled, flexible and effective workforce whilst maintaining high quality and safe care for patients and addresses specific outcomes of the Skills for Health Sector Skills Assessment 2011.

Skills for Health is committed to engaging with employers, professional bodies and other stakeholders in the development of Apprenticeship frameworks. Engagement and consultation is through meetings including face to face and teleconferences and e-consultation. Consultation ensured that employer views are reflected in this framework on the minimum duration, the on and off the job Guided Learning Hours, the inclusion of ICT functional Skills and the use of a qualification to meet the requirements for ERR and PLTS. Apprentices will learn new skills and knowledge whilst carrying out real work as part of the healthcare team. Each apprentice is employed under terms and conditions laid out in an Apprenticeship Agreement between the employer and apprentice (applicable to all apprenticeships that commence after 6 April 2012) and are paid at least the applicable rate under the Apprenticeship National Minimum Wage.

About the role:

Support workers tend to have delegated responsibility for a range of tasks which enables the Health Professionals (eg nurses, doctors, allied health professionals) and the wider healthcare team to fulfil their own roles more effectively.

Healthcare Support Services play a vital part in the smooth running of healthcare services. Individuals undertaking this framework may have a wide range of job roles eg porter, housekeeper/housekeeping assistant, catering manager /assistant, medical records supervisor/clerk, estate manager/worker, etc (this list is not exhaustive). The combined qualification within the framework has been designed in consultation with representatives from the sector so that it is flexible enough to cater for such a broad range of roles.

These are rewarding support roles with a direct impact on patient experience. They also offer an ideal entry route to a wide range of NHS careers.

Aims and objectives of this framework (England)

The apprenticeship framework will contribute towards developing a health sector with a skilled, flexible and effective workforce whilst maintaining high quality and safe care for patients.

Through completion of this apprenticeship learners will gain:

- Broad base training in the chosen occupational area
- Work experience that leads to competency in the work place
- Transferable Skills

Employers have endorsed the apprenticeship programme as it gives the broad base training in

the skills for the occupational area through the completion of qualifications which are based on National Occupational Standards. This programme leads to better productivity, retention and a qualified workforce which aids the employer. Job role and outline can be viewed later in this document (see section 'Jobs').

The framework contributes toward addressing the skills gaps identified in the Skills for Health Sector Skills Assessment 2011.

The apprenticeship programme ensures that learners are supported in the application of their learning directly into the workplace. Learners receive a minimum guaranteed amount of on and off the job training and will acquire transferable skills to support further progression.

The framework specifically supports the need to develop the skills and knowledge of workers at Career Framework levels 1 - 3 and provides career progression routes.

Entry conditions for this framework

There are no specific qualifications required for entry to this apprenticeship framework.

Apprentices should:

- Show enthusiasm for working in the health sector
- Have basic literacy, numeracy and communication skills on which the apprenticeship will build
- Have a suitable level of physical fitness to perform some aspects of the job roles (eg assisting in moving and handling of people)
- Be willing to undergo Disclosure and Barring Service checks (this is needed as apprentices are likely to work with children, young people or vulnerable adults)
- Be flexible as there may be a requirement to work shifts

Individual health sector employers may have additional employment entry requirements e.g. a current driving licence would also be an advantage (and may be necessary for some roles).

Initial Assessment

Training providers and employers will use initial assessment to identify prior learning and experience so that they can tailor the Apprentices's Individual Learning Plan only. This initial assessment will not be used to screen out applicants. Employers may use a separate interview or application process to assess an individual's suitability for employment with the health sector.

Healthcare Support Service Worker	Healthcare support service workers cover a range of areas eg domestic, administration, corporate and estates. Duties may include cleaning, housekeeping, catering, porterage, security, parking, waste disposal, moving equipment and/or individuals, gardening, looking after buildings and machinery.
Ward Clerk	A Ward Clerk will be involved in receiving patients, visitors and other individuals onto the ward. They are likely to use patient administration systems to maintain records and make appointments. They will communicate with patients, members of the public and clinical staff using a variety of means.
Medical/Health Records Clerk	A Health Records Clerk will assist in retrieving and filing health records. This will include exchanging information with staff relating to records, appointments, and admissions. They will require knowledge of patient admissions systems and health records procedures.

Relationship between competence and knowledge qualifications

On completing the above qualification, plus the required units for ERR, PLTS and functional skills, the total number of credits which an apprentice will attain equals 43 which exceeds the statutory required minimum of 37 credits.

Credit Assignment in Mandatory Units Level 2 Certificate in Healthcare Support Services

The minimum requirement of 10 credits of assessed knowledge is met in this framework through the achievement of the mandatory and optional units required to meet the credit threshold. The learner may achieve in excess of the minimum requirement in undertaking the full qualification.

Inclusion of Information and Communications Technology (ICT)

Basic ICT is a life skill that all apprentices should have to work in the modern world. However Functional Skills in ICT does not provide the job specific ICT skills that healthcare employers are seeking. Apprentices should be encouraged to use ICT skills as appropriate during their apprenticeship. Employers are already expected to deliver basic skills in line with their usual practice for other support staff. Apprentices will need to learn tasks such as opening and closing documents, using email and the internet, and inputting and retrieving data from electronic clinical records depending on their role. In the health sector apprentices will very often need to be taught how to use specific local systems in order to do their jobs rather than the more general ICT skills taught in a Functional Skills qualification. These skills will be vital to the apprentice as they continue in their career. Apprentices who are able and willing to achieve a Functional Skills qualification independently or who have the ability to achieve the next level should be encouraged to do so.

PROGRESSION FROM THIS PATHWAY

Learners may progress from this pathway onto further qualifications specific to their work context. A wide range of qualifications are available for use within the health sector. These may include further apprenticeship frameworks (eg Advanced Apprenticeship in Health (Healthcare Support Services), qualifications or other work-related education and training to support Continuing Professional Development.

Progression should not just be seen as vertical. In some instances progressing into another role at the same level may be just as rewarding as it offers the opportunity to develop new skills and knowledge.

Many healthcare support apprentices complete their apprenticeships and continue to work as healthcare support workers in roles relating to the units they have selected within their competence qualification (eg Domestic Assistant, Porter, Catering Assistant, etc).

Others may wish to move into a clinical role and may select to undertake a clinical qualification or apprenticeship (eg Advanced Apprenticeship in Health (Clinical Healthcare Support).

A Higher Apprenticeship in Health (Assistant Practitioner) is available which an apprentice may proceed onto as they progress in their career if they are able to meet the employment and academic requirements. This will enable them to practice as an Assistant Practitioner.

Inclusion of Information and Communications Technology (ICT)

Basic ICT is a life skill that all apprentices should have to work in the modern world. However Functional Skills in ICT does not provide the job specific ICT skills that healthcare employers are seeking. Apprentices should be encouraged to use ICT skills as appropriate during their apprenticeship. Employers are already expected to deliver basic skills in line with their usual practice for other support staff. Apprentices will need to learn tasks such as opening and closing documents, using email and the internet, and inputting and retrieving data from electronic clinical records depending on their role. In the health sector apprentices will very often need to be taught how to use specific local systems in order to do their jobs rather than the more general ICT skills taught in a Functional Skills qualification. These skills will be vital to the apprentice as they continue in their career. Apprentices who are able and willing to achieve a Functional Skills qualification independently or who have the ability to achieve the next level should be encouraged to do so.

On completion of this pathway, learners may progress onto further qualifications specific to their work context. A wide range of qualifications are available for use within the health sector. These may include further qualifications, a range of higher education qualifications or other work-related education and training to support Continuing Professional Development.

Progression should not just be seen as vertical. In some instances progressing into another role at the same level may be just as rewarding as it offers the opportunity to develop new skills and knowledge.

Many healthcare support services apprentices complete their apprenticeships and continue to work as healthcare support workers in roles relating to the units they have selected within their competence qualification (eg Housekeeper/Domestic Supervisor, Senior Porter, Catering Manager, HSDU Technician etc). Many of these roles supervise the work of other team members.

Others may select to undertake further training to move into a clinical role.

To become a Health Professional (eg Nurse, Allied Health Practitioner, Healthcare Scientist) apprentices would have to progress from their apprenticeship to undertake a specific qualification, often a 3-year university Degree, which, on completion, would enable them to register as a professional. To do this, individuals would have to meet the specific entry qualifications as outlined by their chosen Higher Education Provider.

A Higher Apprenticeship in Health (Assistant Practitioner) is available which an apprentice may proceed onto as they progress in their career if they are able to meet the employment and academic requirements. This will enable them to practice as an Assistant Practitioner.

Apprentices who wish to progress into Higher Education are encouraged to complete GCSEs in English and Maths instead of Functional Skills. GCSE qualifications are widely recognised across the Higher Education Sector and support progression into healthcare undergraduate

Skills for Health expect equality, diversity and inclusion to underpin recruitment and employment of all Apprentices in the NHS and through contractual relationships with non-NHS organisations - whether they are directly employed or employed by a third party and undertake placements in NHS setting.

This can be achieved through the use of the Equality Delivery System for the NHS for NHS organisations, or similar equality delivery systems in place with non NHS employers or education providers. The use of such systems ensure that processes for recruitment and uptake are compliant with legal requirements, are fair, inclusive and transparent; that levels of pay are fairly determined; learners are free from abuse, harassment, bullying and violence, and are supported to remain healthy. Above all, Skills for Health will strive to embed equality within its internal organisational processes.

There is a gender imbalance within the health sector, which is a predominantly female workforce. All jobs are open to both males and females and are advertised accordingly. Male role models are positively promoted through marketing materials, photos and case studies. However, a perception that certain job roles are for women remains and this may prevent some males from applying to work in these job roles. Local apprenticeship programmes may



be designed by employers to encourage a higher number of male applicants into these roles and into the workforce as a whole.

Skills for Health is not aware of any other imbalance in the take up of this particular framework eg by ethnic groups. For all health apprenticeships local recruitment is encouraged to reflect the local community.

It is recommended that employers/providers conduct an exit interview if the apprentice leaves the programme before completion. During the learner's exit interview, it is recommended that information on learners leaving the programme before completion is identified and used to support the learner and develop the provision where necessary.

On and off the job guided learning (England)

Total GLH for each pathway

GLH are delivered during contracted working hours. The normal working week in the Health Sector is 37.5 hours. If an Apprentice is employed part-time, the Apprenticeship must be extended in order for the apprentice to complete the GLH.

Intermediate Apprenticeship: To satisfy the requirements of this apprenticeship framework and pathway an apprentice will need to complete a total of 325 Guided Learning Hours (GLH). This total includes both the on and off-the-job guided learning that is to be completed over 12 months.

From August 2012 the minimum expected duration for apprentices on the Intermediate Apprenticeship is 12 months.

Advanced Apprenticeship: To satisfy the requirements of this apprenticeship framework and pathway an apprentice will need to complete a total of 435 Guided Learning Hours (GLH). This total includes both the on and off-the-job guided learning that is to be completed over 18 months. A minimum of 280GLH must be delivered during the first 12 months. The remaining 15GLH should be delivered during the second year.

From August 2012 the minimum duration for apprentices on the Advanced Apprenticeship is 18 months.

Minimum off-the-job guided learning hours

- City & Guilds Level 3 Award in Employment and Personal Learning Skills in Health (qualification number 600/1854/9)
- FAQ Level 3 Award in Employment and Personal Learning Skills in Health (qualification number 601/0957/9)
- Skillsfirst Level 3 Award in Employment and Personal Learning Skills in Health (qualification number 600/6220/4)
- Pearson BTEC Level 3 Award in Employment and Personal Learning Skills in Health (qualification number 600/9666/4)
- IAO Level 3 Award in Employment and Personal Learning Skills in Health (qualification number 601/5971/6)

These qualifications are nationally recognised and were developed specifically to deliver the ERR and PLTS requirements of apprenticeships.

Other Awarding Organisations may offer suitable alternative qualifications in future and the framework document will be updated when these are available.

Creative thinking

Intermediate Apprentices: If the learner is completing the Level 2 qualification they must select and complete the unit 'Using enquiry and investigative techniques to solve problems' which will demonstrate their Creative Thinking skills.

If the learner is completing the Level 3 qualification they must select and complete the unit 'Using research skills to solve problems'.

Advanced Apprentices: from the range of units included within the qualification, learners must select and complete the unit 'Using research skills to solve problems' which will demonstrate their Creative Thinking skills.

The outcomes of the Creative Thinking PLTS are that the apprentice will:

- think creatively by generating and exploring ideas, making original connections
- try different ways to tackle a problem, working with others to find imaginative solutions and outcomes that are of value

Independent enquiry

Intermediate Apprentices: If the learner is completing the Level 2 qualification they must select and complete the unit 'Using enquiry and investigative techniques to solve problems' which will demonstrate their Independent Enquiry skills.

If the learner is completing the Level 3 qualification they must select and complete the unit 'Using research skills to solve problems'.

Advanced Apprentices: from the range of units included within the qualification, learners must select and complete the unit 'Using research skills to solve problems' which will demonstrate their Independent Enquiry skills.

The outcomes of the Independent Enquiry PLTS are that the apprentice will:

- think creatively by generating and exploring ideas, making original connections
- try different ways to tackle a problem, working with others to find imaginative solutions and outcomes that are of value

Reflective learning

Intermediate Apprentices: If the learner is completing the Level 2 qualification they must select and complete the unit 'Manage own learning' which will demonstrate their Reflective Learning skills.

If the learner is completing the Level 3 qualification they must select and complete the unit 'Manage own learning'.

Advanced Apprentices: from the range of units included within the qualification, learners must select and complete the unit 'Manage own learning' which will demonstrate their Reflective Learning skills.

The outcomes of the Reflective Learning PLTS are that the apprentice will:

- evaluate their strengths and limitations, setting themselves realistic goals with criteria for success
- monitor their own performance and progress, inviting feedback from others and making changes to further their learning

Team working

Intermediate Apprentices: If the learner is completing the Level 2 qualification they must select and complete the unit 'Participating in teamwork' which will demonstrate their Team Working skills.

If the learner is completing the Level 3 qualification they must select and complete the unit 'Participating through team leading'.

Advanced Apprentices: from the range of units included within the qualification, learners must select and complete the unit 'Participating through team leading' which will demonstrate their Team Working skills.

The outcomes of the Team Working PLTS are that the apprentice will:

- work confidently with others, adapting to different contexts and taking responsibility for their own part
- listen to and take account of different views
- form collaborative relationships, resolving issues to reach agreed outcomes

Self management

Intermediate Apprentices: If the learner is completing the Level 2 qualification they must select and complete the unit 'Manage own learning' which will demonstrate their Self Management skills.

If the learner is completing the Level 3 qualification they must select and complete the unit 'Manage own Learning'.

Advanced Apprentices: from the range of units included within the qualification, learners must select and complete the unit 'Manage own Learning' which will demonstrate their Self Management skills.

The outcomes of the Self Management PLTS are that the apprentice will:

- organise themself, showing personal responsibility, initiative, creativity and enterprise with a commitment to learning and self-improvement
- actively embrace change, responding positively to new priorities, coping with challenges and looking for opportunities

Effective participation

Intermediate Apprentices: If the learner is completing the Level 2 qualification they must select and complete the unit 'Participating in teamwork' which will demonstrate their Effective Participation skills.

If the learner is completing the Level 3 qualification they must select and complete the unit 'Participating through Team Leading'.

Advanced Apprentices: from the range of units included within the qualification, learners must select and complete the unit 'Participating through Team Leading' which will demonstrate their Effective Participation skills.

The outcomes of the Effective Participation PLTS are that the apprentice will:

- actively engage with issues that affect them and those around them
- play a full part in the life of their school, college, workplace or wider community by taking responsible action to bring improvements for others as well as themselves

Additional employer requirements

There are no additional employer requirements for this apprenticeship framework.
